

## **RULES & REGULATIONS**

**Eligibility requirements:** Eligible recipient organizations must be located in and serve communities in the Erie, PA area and must be recognized by the United States I.R.S. as a 501(c)(3) public charity (excluding the organization types listed in the "Ineligible Recipient Organizations" section) or be accredited public or non-profit schools, school districts, colleges, and universities to which contributions are tax deductible under the Internal Revenue Code of the United States (excluding the organization types listed in the "Ineligible Recipient Organizations" section).

The following are not eligible to participate: 1) Political organizations 2) Organizations primarily promoting religious purposes; requiring participants to be of a certain faith or to participate in programs or receive services; or delivering social services with prayer, proselytization or other specifically religious activities. 3) Donor advised funds, private foundations, personal trusts. 4) Organizations that do not comply with the ERIEBANK non-discrimination policy (i.e. organizations that discriminate on the basis of a person's race, color, religion, national origin, gender, sexual orientation, age, disability, veteran status or other characteristic protected by law). 5) Organizations that do not comply with the U.S. Patriot Act. 6) ERIEBANK reserves the right to examine and exclude organizations as it deems appropriate.

Terms & Conditions: ERIEBANK reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the contest should virus, bug, non-authorized human intervention, fraud, or other cause beyond ERIEBANK's control corrupt or affect the administration, security, fairness, or proper conduct of the contest. Each will receive a minimum award of \$500. The organization with the most online votes will receive \$3,000; the organization with the second highest number of votes will receive \$1,500; and third highest will receive \$1,000. The remaining five organizations will each receive \$500.

**Winner notice:** Following the nomination process, the 8 Great Charities will be announced on Tuesday, July 17, 2018. Awards will be announced and presented at the 8 Great Tuesdays concert on August 21, 2018. Each recipient organization must have a representative present at the event to accept the award onstage.
